Master Beef Producer Classes

For the upcoming 2024 TAEP, anyone who has completed the Master Beef Producer Program or one of the other qualified Masters Programs in 2021 or after are current in their certification. **BQA is no longer required to apply for TAEP** and will become part of the Master Beef Producer Class. An approved Masters Certification will now be required at the time of re-imbursement and all TAEP grants will be paid at the 50% level. If you are not current in your certification or have never taken the class there are several Master Beef Producer Classes that are scheduled.

There will be 2 face-to-face opportunities this fall for producers to complete the Tennessee Master Beef Producer Class.

- 2 Day Version---Monday evening Sept. 23 and Tuesday all day Sept. 24. The location will be at the Middle Tennessee Research & Education Center in Spring Hill. On Tuesday we will use the Beef & Forage Field Day as part of our class.
- Monday Evening Version Monday, Sept. 23, Monday, Sept. 30, Monday, Oct. 7 & Monday, Oct. 14. Each evening class will begin at 5pm. The locations will rotate between Spring Hill, Pulaski & Lawrenceburg.

A fall virtual class will be offered as well by the UT Extension Beef Specialists beginning on September 3rd. The 2024 Master Beef Fall Webinar Series will be on Tuesdays and Thursdays at 6:30 PM Eastern/5:30 PM Central, starting September 3rd and ending September 26th, for a total of 8 webinars. Participants must attend at least 7 of the 8 classes for Master Beef Certification. The cost for the virtual class will be \$100.

2024-2025 TAEP Highlights

The 2024-2025 TAEP Applications will soon be available on-line. One big change this year is that all TAEP applications must be submitted on-line. There will no paper booklet applications available and producers will not be able to submit applications through regular mail. Applicants must have a valid email address to apply on-line. If you don't currently have an email address you can establish one or use a family members address.

The TAEP application period is October 1-7. For those who may need assistance in applying online you can contact the Extension Office at 762-5506 and schedule a time to come by for assistance. I have set aside 2 days to assist those that need help applying on-line: Wednesday, Oct. 2 and Monday, Oct. 7.

Some notable changes to this year's program:

 All TAEP applications must be submitted on-line and producers will need a valid email address, access to both an electronic device and the internet.

- 2. BQA Certification will no longer be required to apply for TAEP and will become a part of the Master Beef Producer Program.
- 3. An approved Master's Certification will now be required by all applicants at the time of re-imbursement and all grants will be paid at the 50% level.
- 4. Both Hay Storage and Hay Equipment will be offered and qualified producers can apply for either this year.
- 5. The eligibility for hay equipment has changed and only producers that cut 100 acres of first cutting hay can apply.
- 6. For Hay storage there is now a 1200 sqft minimum and only stand-alone sheds will be allowed. Side sheds to existing structures will not be eligible.
- 7. Bush Hogs have been added to the livestock equipment list and must be a minimum of 8ft.
- 8. GPS's have been removed from both the Row Crop and the Livestock Equipment programs.

Livestock Producers in Lawrence County Are Eligible for Drought Recovery Assistance

The U.S. Department of Agriculture (USDA) Farm Service Agency (FSA) in Lawrence County has announced that FSA is now accepting applications for the <u>Livestock Forage Disaster Program</u>

(LFP) for grazing losses due to drought. The deadline to apply for 2024 LFP assistance is January 30, 2025.

LFP provides compensation to eligible livestock producers who suffered grazing losses for covered livestock due to drought on privately owned or cash leased land or fire on federally managed land. For LFP, qualifying drought intensity levels are determined using the <u>U.S.</u>

<u>Drought Monitor</u>. Producers in Lawrence County are eligible to apply for 2024 LFP benefits for grazing losses on native pasture, improved pasture mixed forage, and forage sorghum. Visit the <u>FSA LFP webpage</u> for a full list of eligible counties and pasture types.

Livestock eligible for LFP include alpacas, beef cattle, bison, buffalo, beefalo, dairy cattle, deer, elk, emus, equine, goats, llamas, ostriches, reindeer, or sheep that have been or would have been grazing the eligible grazing land or pastureland. Recently, FSA updated LFP policy to expand program eligibility to include additional income producing grazing animals, like horses and ostrich, that contribute to the commercial viability of an agricultural operation.

Livestock used for hunting and consumption by the owner and horses and other animals that are used or intended to be used for racing and wagering remain ineligible.

As a reminder, producers who want to participate in many USDA programs including disaster assistance programs like LFP, must file timely acreage reports by filling out the FSA-578 form to remain eligible for program benefits. Livestock producers interested in applying LFP should contact the Lawrence County FSA at 931-762-6913 Ext #2 with any questions about the eligibility of specific livestock and forage crops.

Fall Forage Challenges

Pastures and hayfield are showing the extreme results of our lack of rainfall and extended drought conditions. Rotational grazing if possible is highly encourage to rest stressed forage and give cattle a fresh source of nutrition. If we do get moisture in the next few weeks and grass starts growing, it may still provide an opportunity for stockpiling fescue. This strategy will only work if we do get ample moisture before it gets too late as we get into late September and into early October. Continue to be cautious and keep a look out for the fall armyworms. The first reports of the fall armyworms started coming in early August in all parts of the county. These reports have slowed in recent days as we have been getting dryer but producers are encouraged to remain on high alert as we are nearing the time for the second generation to emerge. Another concern for forage producers in dealing with drought conditions is the potential of forage plants accumulating nitrates. As plant growth slows due to extreme drought conditions the plants retain nitrogen in the form of nitrates which can be toxic to livestock. The plants most susceptible to nitrate toxicity are the sorghum/sudan grass hybrids, millets and johnsongrass. The chance of the plants accumulating nitrates is correlated to the amount of fertilizer (nitrogen in particular) and the extreme conditions of the drought slowing the plant growth. If you have a concern about your forage and nitrates contact me at the Extension Office. We have a very simple test that can be done to check for the potential of nitrates in your forage.

Lastly producers need to be ramp up their awareness of potential toxic plant issues. As the drought conditions continue and livestock get hungrier, they are more apt to consume toxic plants. One of our most common toxic plants that is seen in Lawrence County pastures is Perilla Mint. Perilla Mint causes more cattle deaths in Tennessee than any other toxic plant.
